If you love crafting and want to make a real difference in your community, why not put your talents to good use? I am currently working on two crafting projects: crocheting blankets for babies in the Neonatal Intensive Care Unit (NICU) and making paracord lan-

yards for service members and first responders. Let me tell you how you can start helping your community through crafting.

Crocheting blankets does not require many materials. All you'll need is one crochet hook and some yarn. Most people use

a crochet hook size of 4.5 mm to 5.5 mm, and you should try to get 100% cotton yarn, as it's the best type of yarn for babies, but acrylic yarn is also accepted in hospitals. (Just be sure to check the specific requirements of the place you're donating to.) You can send your donations to local hospitals or non-profit organizations, such as Knots of Love. The soft, handmade blankets that you make for the newborns in the NICU will be used to keep the babies warm since they aren't able to regulate their own temperature. Parents often sleep with the blanket to transfer their scent so that when the babies use them, it helps the baby feel more connected to the parent. It's a way to send warmth-both physical and emotional-to families in need.

For a paracord lanyard, you would need a few simple materials: the paracord, a scissor, a lighter, and a measuring device, such as a metric ruler. Cut five feet of the lanyard, braid it, and seal the ends off with a lighter to prevent fraying. These small but mighty paracord lanyards are used by service members and first re-

sponders in all sorts of emergency situations-whether it's to secure camouflage nets to trees or hang an IV bag from a tree. If you cut open the paracord lanvard to the thinner strings on the inside, they can be used as a suture to close wounds in emergency situations or as a sewing thread to repair gear. And there's a bonus. For every five paracord lanyards you make, you can get one hour of community service through a non-profit called Operation Gratitude. You can view the tutorial on Operation Gratitude's website to learn how to make the lanyards. Once you've made a few, you can mail them to Operation Gratitude's address in Chatsworth, California. Your lanyards will be put to good use by service members and first responders on the field.

Whether you're experienced with crafting or just starting out, both of these projects are a great way to give back to your community. They don't just create something beautiful—they create a meaningful connection to those in need. So grab your crochet hook and some paracord, and let's start crafting for a cause!

The Dangers of Fentanyl for Students

On September 13th, tragedy struck Bernstein High School. A student was found on campus, unresponsive, due to a fentanyl-induced overdose. This is an all too familiar situation that has been a rising problem since the start of the pandemic, with cities recording higher rates of drug overdoses each year. Despite these increased rates, the rates of opioid misuse have decreased. But how?

While discussing this with a

teacher at my school, we recognized that fentanyl is extremely potent, being about a hundred times stronger than morphine. The main reason this FDA drug has become more dangerous is because it is used to lace counterfeit medicine. Individuals hoping for cheaper sources of medication are often unaware of the lethality of these pills. Most users can access these pills online easily, unbeknownst to how deadly they could be. These pills have a two in five chance of carrying a deadly dosage that could potentially kill the user. The reason why this opioid has been considered so dangerous is because such a small dosage can rapidly end someone's life.

Circling back to the devastating incident at Berstein High School, we concluded that many teens utilize fentanyl as a "quick fix," a way to get high and escape reality. This is most likely rooted in the growing depression and mental health issues among the youth of our country. Many of these drugs originate in China, where they then ship the ingredients to Mexico for production. Once the pills have been mass-produced, they make a trip across the border to dealers across the United States. Just like that, these pills are now easily accessible online and on social media apps. This raised a question regarding the policies my school and district have started to enforce to prevent future incidents like these.

The Los Angeles Unified School District (LAUSD) has served as a role model for districts across the nation when dealing with fentanyl. Led by the Chief Medical Officer, Dr. Malhotra, Superintendent Carvalho and board members of LAUSD have ensured that each school across the district has feasible access to Narcan, an antidote used in opioid overdoses. This was proven to be a life-saving initiative that saved 31 lives this past year.

To find out the type of safety measures my school had made, I decided to ask my school's vice-principal, Mr. Rosenthal. He informed me that our campus

has 7 boxes of Narcan across our campus, accompanied by an automated external defibrillator (AED). I was also surprised to find out that a mobile kit of Narcan and AED was also created for athletic activities on the field. All staff and students were provided with training on "Substance Use Awareness/Fentanyl", where they trained on the procedure to administer Narcan.

As studied in 2021 by NCBI, more than 61% of university students in the U.S. note a fear of speaking in public. Since public speaking has become prevalent in a variety of careers in society, it is essential to address this self-conflict that many encounter.

At a young age, children de-

velop and overcome many different fears and cautions. An example would include a fear of the dark or a fear of monsters, which typically alleviate as the child matures. However, it is difficult for a child to overcome the social anxiety of public speaking until it is directly confronted and

This becomes a wonderful opportunity for students to address any social fears they may have and even seek a

good out of it.




their devices.
